2. The Bartholomew County Solid Waste Management District shall indemnify and hold Project Volunteer free and harmless from all claims, liability, loss, damage, or expense resulting from the Adopt-a-Highway project.

Adopt-a-County Road Program Sign-Up Agreement**

**What you provide...**

1. \_\_\_\_\_ pledges to clean-up a one and one-half mile stretch of County roadway siding located at \_\_\_\_\_ within Bartholomew County a minimum of two times per year for a period of at least 2 years duration.
2. Agree to a hold harmless agreement with the District for any liability associated with the clean-up.
3. Adequate number of qualified volunteers (suggest 8-15)(No volunteers under age 16 allowed).
4. Notification to the District of your intent to perform the cleanup at least 2 weeks prior to the event.
5. Adequate safety training to all your volunteers explaining the risks of working alongside a roadway.

**What we provide.....**

1. Signage at both ends of the collection area proclaiming your group's dedication to making our District a cleaner, healthier place to live.
2. Plastic bags for collection events.
3. Returnable high-visibility safety vests.
4. Gloves
5. Pick-up of trash bags the day after the collection event.
